2	<p>Presidents Report</p> <p>Hello Everyone! Thank you for attending this meeting. Firstly I would like to thank all the committee for their hard work this year. I would also like to thank those members who lead rides; Neil Coleman, Dean Attwood, and Glen McGeachen.</p> <p>I feel this year has been a bit quieter than usual with less members attending rides and less new people joining us. It has been challenging year for those few of us on the committee to carry the burden of running more than a fair share of rides. This is not a sustainable voluntary work load, this will need to be shared around more if we are to continue operating as a club.</p> <p>I am hopeful our work will pay off in the upcoming year, as people get more social and active again after covid. That we will see the number of new members increase and take an active part in the club. Despite this not being much left for the club to use to put towards the clubs objectives, we agreed that it is more important to keep our subs low, to work on increasing our membership back up. Seconded by Steve Approved unanimously</p> <p>Membership Secretary: Raised by Hannah that this role is now obsolete due to the use of Hivepass as a membership system. Membership management can easily be managed by just one person- the Secretary. 	<p>Seconded by Hannah, Approved unanimously.</p> <p>Your committee therefore is as follows: President; Hannah Strickland Treasurer; Henry Glubb Secretary; Mark Neilson Ordinary committee members; Tanya Hyde and Steve Riefe.</p> <p>Committee meetings will be held as required throughout year and all members will be invited. A minimum number of 5 members will need to be present, to cast a vote. This will in-courage all members to be a part of the running of the club, and reflects our low membership numbers, that it is not possible to find that number of volunteers.</p> <p>It was noted that all roles will expire at the next AGM and that it is the responsibility of the club to find suitable people to fill roles.</p>

As we are not sure that any of these will want money or how much it will be up to the committee to research and donate amounts as they see fit.</p> <p>Suggested by Milty;</p> <ul style="list-style-type: none"> -Orton bradley has recently build a bike track. -Rod Donald trust is building tracks from Geebies to Akaroa potentially could be mt bike tracks if access allows. -Paid advertising to grow to club membership to take weight leadership off and more members will mean more trail volunteers generally good for mt biking as a sport. -Refreshments for dig days burger and beers post dig days. -Look into “Movember”, raising money to buy weed eaters or donating one, if a voluntary organisation needs one. <p>Suggested by Tanya;</p> <ul style="list-style-type: none"> -Native plantings on uphill Rapaki possibly using trees that count.
